

Karna - A Critical Analysis of Destiny and Dharma in the Mahabharata

Abstract

Karna remains one of the most complex and tragic figures in the Mahabharata, embodying the profound tension between destiny (daiva) and moral duty (dharma). Born to Kunti yet abandoned at birth, raised by a charioteer's family, and denied recognition of his Kshatriya identity, Karna's life unfolds under the shadow of social marginalization, concealed lineage, and repeated humiliation. At the same time, his unwavering loyalty to Duryodhana, steadfast generosity, and martial excellence render him a figure of ethical depth rather than a mere antagonist.

This paper undertakes a critical analysis of Karna's character to examine how the epic negotiates the interplay between destiny and moral agency. It explores key narrative moments—his allegiance to Duryodhana, participation in the Draupadi, Swayamvara and humiliation faced there. Refusal to abandon the Kaurava cause despite knowledge of his true birth, and his ultimate death on the battlefield—as sites where destiny and conscious ethical choice intersect. By situating Karna within the broader philosophical framework of dharma articulated in the epic, the study interrogates whether he is primarily a victim of inexorable destiny or a moral agent accountable for his decisions.

Drawing upon textual analysis and contemporary interpretative scholarship, the paper argues that Karna represents neither deterministic fatalism nor pure ethical autonomy, but rather a tragic synthesis of both. His life illustrates the epic's nuanced view that while circumstances may be shaped by destiny, moral responsibility persists in the realm of action. Through this exploration, the study contributes to ongoing discussions on ethical ambiguity, social identity, and the tragic dimension of dharma in the Mahābhārata, highlighting the enduring relevance of Karna's dilemma for modern reflections on justice, loyalty, and moral conflict.

2. Literature Review

Rai and KT (2021) reviewed the existing literature on Karna and argued that modern perceptions of the character have since developed out of seeing him as a minor or secondary character to viewing him as a complex, many-dimensional lead in his own right. Their reviews demonstrated that the current historians and authors are redefining Karna increasingly by the prism of psychological depth, ethical conflict, and social marginalization. They demonstrated Karna as both a weak and a strong character by examining such themes as identity crisis, loyalty, gratitude, discrimination grounded on caste, and moral ambiguity. The researchers also noted that Karna had numerous emotional issues, including the desire to be accepted, the need to decide between duty and justice, and the need to be loyal to Duryodhana, which have led to the numerous modern retellings of the story that have aimed to be more understanding of his motives. Their interpretation eventually described Karna as a symbolic character whose life was the ultimate clash of destiny and free will that makes him not only a fighter in the epic, but an intricate character whose story is still popular among the people of today.

Aithal and BR (2024) discussed the concept of the performance punishments in the Mahabharata, which implies that people of great ability and diligent hard work were always foiled by external forces and injustice of the system. Using Karna in their study, they demonstrated that despite his unmatched prowess, courage, and commitment to his deeds, his life continued to be aggravated by profanity, institutionalized discrimination, caste bias and the consequences of his undying allegiance to Duryodhana. They stated that the story of Karna demonstrated the fact that even the most successful people may be restrained by the forces which are outside their power such as strict social order and predetermined destiny. In the research they conducted, Karna was portrayed as a symbol of wasted potential and the poor limitations that society conventions placed upon him.

Govind (2022) conducted an in-depth investigation into the broader moral imagination of the *Mahabharata* and positioned Karna as a central figure through whom the epic interrogates fundamental questions of justice, responsibility, and righteousness. The study argued that the ethical conflicts faced by Karna mirror the deeper philosophical tensions that underpin the text, particularly the complex interplay between personal dharma-shaped by loyalty, gratitude, and

emotional bonds—and universal dharma, which demands fairness, justice, and moral integrity. Govind highlighted that Karna’s choices and persistent inner dilemmas compel readers to critically examine the moral framework of the epic, demonstrating that virtue, duty, and destiny do not operate in isolation but intersect in ways that are often unpredictable and morally ambiguous. Through Karna, the study illustrates how the *Mahabharata* challenges simplistic notions of right and wrong, showing that ethical decision-making is profoundly contextual, shaped by circumstances, relationships, and the unavoidable influence of destiny.

3. Research Methodology

The śloka appears in the Mahābhārata in Ādi Parva, Sambhava Parva, Adhyāya 111, where it describes the moment when Kunti, out of fear of social stigma, places the newborn Karna into the river. This passage is found in Gita Press Edition, Vol. 1, Page 287. This śloka describes the moment After Kunti gave birth to Karna through the boon granted by the sun god (Surya), she feared social stigma and could not reveal his origin. Therefore, she placed the newborn gently upon the earth, just as a turtle lays its eggs on the ground, and left him there. A river flowing nearby carried the baby away, eventually leading him to be discovered and raised by Adhiratha and Radha.

Karna grows up in an impoverished family of a charioteer, even though he was given as a gift the birth of gods. Since he was a young boy, the society would not acknowledge his genius or his natural nobility as there was the stigma attached to his so-called poor position. All his life is devoted to the never-ending search of dignity, identity and recognition. He faces humiliations in the battlefield due to varna prejudice and he misses the social rewards despite his unmatched prowess. Destiny is cruel and comes at every crucial point of his course. He is rejected trying to obtain an education. He may succeed in obtaining the mighty Brahmastra but a curse will make it useless at the very time he needs it the most. In such a manner, Karna turns into a powerful metaphor of how even the most admirable traits could be subdued by the power of destiny, as well as how an individual of an extremely high ability could still find themselves at the mercy of the circumstances, which are not within their power.

शत्रवेऽपि ददात्येष नित्यम् अप्रतिहतं धनम्॥”

The famous verse is found in Karna Parva, Adhyāya 50. It glorifies Karna's extraordinary charity and the title "*Dāna-Veera-Sūra Karna*." This śloka is printed in Gita Press Edition, Vol. 3, Page 121. This verse glorifies the unparalleled generosity of Karna, and says that no man is greater than that of giving. To the extent of giving money away free and without hesitation exhausting his wealth, no matter who is the beneficiary, his charity is so pure and boundless. The sloke emphasizes the greatness of the character of Karna, Dana Karna Veera Karna, because his greatness is not only his warrior qualities but also in his endless compassion and unselfishness. His generosity is described as being unconditional and undying, therefore, he is a unique personality who honors the highest principle of giving without considering who is in front of him. This is one of the most glorified features of the personality of Karna in the Mahabharata.

All through the course of the narrative he is more than aware of the fact that the Pandavas are taking the correct side of the case, that the ambition of Duryodhana will end up in the wrongful rule, that the humiliation of Draupadi was ethically inexcusable and that the war he chooses to go to will cause incalculable havoc. Although Karna knows fully well what it is required of him to do in terms of morality, he opts to remain loyal to Duryodhana, since he believes that to show gratitude is his ultimate personal dharma need. The ethical statement occurs in Karna Parva, Adhyāya 69. Here Karna explains the moral superiority of dying for dharma rather than living through adharma. It appears in Gita Press Edition, Vol. 3, Page 176. The message that can be brought out in this verse is that it is worth more to die as a righteous person than to live as a wrong doer. The speaker states that dharma-related death is much better than a life supported by adharma, and the idea that the moral integrity is the key to the true honour is more important than surviving. They attest that they never select adharma and they never promote or adhere to adharma by any means. The sutta emphasizes how ethical the character is in his/her thoughts, showing us a world of values and ethics, where justice is more important than life itself.

His lifetime identity question, his search of the dignity in the world which refused him the respect and his sensuous gratitude to the one, who was ready to understand his value all helped to create his dharma, which is very situational and personal one. Due to this, the meaning of dharma to Karna changes it into a more relational and not a universal one, and it is based on relationships as opposed to moral principles that cannot be challenged. The verse is recorded in Udyoga Parva, Adhyāya 146. Karna tells Krishna that he does not desire the Pandava kingdom and will not betray Duryodhana. This śloka is available in Gita Press Edition, Vol. 2, Page 580. In this verse, Karna says that he does not want the kingship of the Pāṇḍavas and is addressing Janamejaya and it is clear that power or royalty

does not attract him. The friendship and the grace that he got once at the hands of Duryodhana is what he treasures most. Karna underlines that the honour, dignity and status that were given to him by his friend, through generosity must never be forsaken even when the alternative looks so appealing. This remark indicates the deep feeling of gratitude and fidelity in Karna and that he does not want to realize his own ambition and instead choose to be faithful to his benefactor even when offered the throne of the Pāṇḍavas. In this, the verse shows the breadth of the character of Karna, who was uncompromising, undying, and unflinching in valuing the people who were by his side.

He has built his whole life on the basis of gratitude and loyalty and in his opinion, were he to abandon Duryodhana, who rescued him of social infamy and granted him honor, he would stand a traitor in the sight of dharma itself as well as of his own conscience. Despite the fact that he was born, his sense of responsibility, which was developed throughout the years of emotional and moral attachment and dedication to him, prevails. This moment not only gives evidence to the amazing moral courage that Karna has, but also proves the tremendous burden that destiny has as his prisoner. Due to his choice to act in the best interest of his people, even though he knows that this path will eventually make him ruinous, his tragedy is deemed as one of the most heartrending in the epic tradition.

4.4 Destiny and free will coexist

In his desperate efforts to free the wheel the curse of Parashurama comes and he loses the incantation to the Brahmastra just when he is most in need of it. In this helpless state, when unarmed and naked, Karna pleads to be given an opportunity to be treated fairly by referring to the principles of dharma to which he has always been devoted. But Krishna, who knows that dharma needs to be flexed in order to bring back the population of the universe, advises Arjuna to launch the fatal arrow.

This event in particular is not only a military failure, but it is the figurative climax of all the denials and torments and sorrows that Karna has undergone in terms of his life. The last piece of evidence of the fact that destiny is more powerful than people is his downfall, reminding the reader that even the most powerful heroes are not able to get out of the nets that destiny creates.
