





#### 1. Variance:

- Variance is a statistical measure that describes how much each number in a dataset deviates from the mean (average) of the dataset.
- It quantifies the dispersion or spread of a set of data points. A higher variance indicatesthat the data points are more spread out from the mean.

#### 2. Covariance:

- Covariance is a measure of how much two variables change together. If positive, it indicates that as one variable increases, the other tends to increase as well. If negative, it indicates that as one variable increases, the other tends to decrease.
- Covariance is sensitive to the scale of the variables, making it difficult to interpret in isolation. It's often used in conjunction with correlation.

### 3. Beta:

- Beta is a measure of a stock's or portfolio's sensitivity to market movements, specificallythe benchmark index (often the market index like the S&P 500).
- A beta of 1 implies that the stock or portfolio tends to move with the market. A beta greater than 1 indicates higher volatility (amplified movements compared to the market), while a beta less than 1 suggests lower volatility.
